PETITION FOR CONTEMPT AND ORDER TO SHOW CAUSE

COMES NOW, The Florida Bar, Complainant, in the above-referenced matter, pursuant to Rule 3-7.11(f), Rules Regulating The Florida Bar, and files this Petition for Contempt and Order to Show Cause, and states the following:

1. A copy of the Grievance Committee Finding of Non-Compliance and Failure to Respond to Official Bar Inquiries and Contempt is attached to this Petition as "**Exhibit 1**".

2. As of the date of the service of this Petition, Respondent has failed to respond to official Bar inquiries.

3. The other members of The Florida Bar should not have to pay for Respondent's failure to respond to official bar inquiries and the initiation of the instant proceeding. Therefore, the Bar is requesting administrative costs of **\$1,250.00** against Respondent.

WHEREFORE, The Florida Bar requests that this Court suspend the Respondent pursuant to Rule 3-7.11(f), until such time as he fully responds in writing to the official Bar inquiries contained in “**Exhibit 1**” and until further order of this Court.


