### THE FLORIDA BAR'S FORMAL COMPLAINT

The Florida Bar, Complainant, files this Complaint against Kenneth Joseph Kukec, Respondent, pursuant to the Rules Regulating The Florida Bar and alleges:

1. Respondent is, and at all times mentioned in the complaint was, a member of The Florida Bar, admitted on November 14, 1986, and subject to the jurisdiction of the Supreme Court of Florida.

2. Respondent is currently suspended from the practice of law by orders of this Court dated March 2, 2017, April 17, 2017, and September 22, 2017.

3. For all times material hereto, Respondent resided and practiced law in Miami-Dade County, Florida.

4. The Eleventh Judicial Circuit Grievance Committee "A" found probable cause to file this complaint pursuant to Rule 3-7.4, of the Rules

Regulating The Florida Bar, and this complaint has been approved by the presiding member of that committee.

5. This proceeding stems from a January 2016 complaint by a client of Respondent's.

6. Respondent was retained by the client in April 2013 to pursue an appeal of a criminal conviction.

7. The Appellate Court docket reflects record activity by Respondent on behalf of the client until the conviction was ultimately affirmed and a mandate issued in December 2015.

8. The client's chief complaint is that Respondent failed to return telephone calls and answer any of his written communications.

9. Respondent failed to respond to the written inquires of The Florida Bar requesting evidence that Respondent returned telephone calls or responded to the client's written communications.

10. While there is record activity by Respondent on the docket of the client's criminal proceedings, there is no evidence that Respondent returned telephone calls to the client or answered any of the client's written communications.

By reason of the foregoing, Respondent has violated the followingRules Regulating The Florida Bar:

- a. 4-1.4(a) (Communication)
- b. 4-8.4(g) (Misconduct)
