NOTICE OF DETERMINATION OR JUDGMENT OF GUILT

COMES NOW, The Florida Bar, and files this Notice of Determination or Judgment of Guilt, pursuant to Rule 3-7.2(f), Rules of Discipline of The Florida Bar and says:

1. Respondent is a suspended member of The Florida Bar, admitted on April 25, 2011.
2. On or about January 7, 2019, in State of Florida v. William J. Scheil, Case No. 2018-CF-8, in the Circuit Court of the Fifth Judicial Circuit, in and for Lake County, Florida, Respondent entered a written plea of nolo contendere to Possession of Heroin (a third degree felony) and Possession of Paraphernalia (a misdemeanor).
3. On or about January 7, 2019, the court withheld adjudication on the Possession of Heroin charge and adjudicated Respondent guilty on the Possession

of Paraphernalia charge. The court sentenced Respondent to seven days imprisonment (time served), 24 months of probation, incarceration costs, and court costs. A copy of the Judgment and Sentence is attached hereto as Exhibit "A."

WHEREFORE, The Florida Bar respectfully requests that this Court enter an order:

1. Finding Respondent guilty of violating Rule 4-8.4(b) (A lawyer shall not commit a criminal act that reflects adversely on the lawyer's honesty, trustworthiness or fitness as a lawyer in other respects) of the Rules Regulating The Florida Bar;

2. Suspending Respondent pursuant to Rule 3-7.2(f), Rules of Discipline of The Florida Bar (Respondent is currently suspended pursuant to a Court order dated December 28, 2017); and

3. Appointing or directing the appointment of a referee to conduct a hearing on sanctions pursuant to Rule 3-7.2(h), Rules of Discipline of The Florida Bar.
